Sales conditions and payment terms

A. You are an end user

- ORDERING DATES: ALL YEAR AROUND.
- PAYMENT METHOD: SWIFT TELEX WIRE TRANSFER or bank checks according to countries
- DELIVERY DATE: AS SOON AS PAYMENT RECEIVED
